

## The PA PQC recommends to consider one of the following validated SUD screening tools:

4Ps
4Ps Plus©
5Ps¹
NIDA Quick Screen²
Substance Use Risk Profile Pregnancy (SURP-P) Scale
CRAFFT (for adolescents)
Wayne IDUS
DAST-10
Prenatal Risk Overview-Drug Use (PRO)

<sup>1.</sup> If providers elect to use the "<u>Institute for Health and Recovery Integrated Screening Tool</u>" (which is also known as the "Integrated 5Ps Screening Tool"), this includes the 5Ps.

<sup>2.</sup> A positive response on the <u>NIDA Quick Screen</u> leads into the NIDA-Modified ASSIST. (It is a two-step screening process.)
