% NICU or well-baby nurses trained in validated NAS assessments

75% vs. 95% (120% points)

% with QI effort to increase NAS assessment inter-rater reliability

19% vs. 59% (141% points)

Use standardized pharmacologic protocols for NAS

82% vs. 93% (111% points)


Use standardized non-pharmacologic protocols for NAS

Percentage of Newborns with NAS Referred to Appropriate Follow-up at Discharge




PA PQC Teams Improved Adherence to Non-pharm Care as 1st Line of Treatment (e.g., skin-to-skin contact)

Use a validated, self-report screening tool for substance use in pregnancy

48% vs. 97% (148% points)


Provide opioid pharmacotherapy for pregnant women with OUD

59% vs. 84% (124% points)

PA PQC Teams Put in Place a Structure to Offer Immediate Postpartum LARC (IPLARC)

As of March 2022

Among the 17 submitted the surveys,

12 hospitals achieved the 1st goal
and are now routinely counseling, offering, and providing
immediate postpartum LARC

IPLARC Improvement Opportunities

Second Goal: Increase access to IPLARC among eligible individuals desiring IPLARC

- Hospitals that achieved the 1st Goal are now working to improve their contraceptive care and counseling processes and track and report data for the process measures
 - ✓ 5 hospitals in the IPLARC initiative have submitted data for the process measure:
 - % of induvial who desired IPLARC who received a LARC device prior to discharge

PA PQC MOMD Teams Initiating QI Initiatives to Reduce Disparities

Majority of MOMD teams (88%) started with universal depression screening in place

High Percentage of MOMD Teams Saying Yes for follow-up processes to:

Referral to Mental Health 88%

Refer to Community Resources 81%

MOMD teams initiated QI initiatives to close gaps in disparities:

Stratifying depression measures by race/ethnicity

75% (yes or working on it)

Conducting QI projects to reduce disparities

69% (yes or working on it)

Working with patient/family advocates or community resources to inform processes 44% (yes or working on it)




