# Focus for Today's Virtual Meeting



Additionally, two of the recommendations from the PA MMRC found the following strategies to be beneficial to preventing overdose deaths:

- 1) "Standardizing discharge plans for all hospitals stays for pregnant and postpartum patients with OUD, or a prescription for an opioid, to include distribution or prescription for naloxone, instructions on how to use and where to get naloxone when needed," within healthcare provider offices and hospital systems.
- "Increasing community knowledge of naloxone, including information on procurement and instructions for use" for community-based organizations.

# Maternal SUD Driver Diagram Naloxone Key Interventions

#### **Driver**

**For Educate patients and their families** on substance use and the care of infants with in-utero substance exposure

Equip patients/families with resources to save lives

#### **Key Interventions**

- Provide evidence-based education to pregnant and postpartum individuals related to SUD, naloxone use, harm reduction strategies, and care of infants with in-utero substance exposure
- Provide education for best practices for engaging and treating pregnant and postpartum individuals who themselves have an FASD\*

Establish policies and protocols to provide Naloxone to anyone who may witness an overdose




